***Re: Application for Approval under Section 1779(AE) of the Planning and Development Act 2000 (as amended) for the Proposed Upgrade of a Section of the Existing Access Roadway at Wexford Wildfowl Reserve, North West Slob, Ardavan, Wexford, Co. Wexford.***

Pursuant to the requirements of Section 177AE(4)(b) of the *Planning and Development Act 2000* (as amended) and as set out in Article 121 of the *Planning and Development Regulations 2001* (as amended), we hereby give notice that an application for approval has been made to *An Bord Pleanála* in respect of a proposed development at Wexford Wildfowl Reserve, North West Slob, Ardavan, Wexford, Co. Wexford.

The proposed development comprises works which are summarised as follows:

- Excavation of existing surface to formation levels and placing and compaction of base course and wearing course macadam overlay along 842 linear metres of the existing roadway.
- Construction of side drains along the northern edge of the sections of roadway to be upgraded.
- Reinstatement of grass margins in areas adjacent to constructed side drains.

***An Appropriate Assessment Report Comprising a Stage 1 Screening Report and Stage 2 Natura Impact Statement (NIS)*** has been prepared as part of the application for approval in respect of the proposed development.

*An Bord Pleanála* may give approval to the application for development with or without conditions or may refuse the application for development.

Submissions and observations on the proposed development may be made to ***An Bord Pleanála*** in relation to:



1. The implications of the proposed development for proper planning and sustainable development in the area concerned,
2. The likely effects on the environment of the proposed development, and
3. The likely significant effects of the proposed development on a European Site, if carried out,
